THE COMPLAINANT, TERRY LOVELL, STATED THAT ON 11-28-98 AT APPROXIMATELY 130 HOURS, BRIANNE SCARBER RETURNED TO HER RESIDENCE AT 71 JONES BEND RD. WITH A FLAT TIRE.
