7:15 PM- JOEY WATKINS CALL HIS GIRLFRIEND ON THE CELL PHONE. THE CALL GOES THROUGH THE KINGSTON TOWER.

QUESTIONS TO BE ANSWERED

1. WHY DID JOEY CALL HIS GIRLFRIEND AT 7:15 ON THE CELL PHONE IN HIS STATEMENT HE TOLD MIKE KEY THAT HE DIDNT LEAVE THE HOUSE TO GO TO HER HOUSE UNTIL 7:20. THIS CONVERSATION LASTED 4 MINUTES AND 25 SECONDS. HIS STATEMENT TO MIKE KEY WAS THAT HE CALLED HER WHEN HE GOT HOME FROM FISHING. AND THAT SHE ALSO CALLED BACK AND TIM HUGHES ANSWERED THE PHONE WHILE HE (JOEY WAS IN THE SHOWER). THIS CELL PHONE WAS 5 MINUTES BEFORE THE CALL CAME IN TO 911 ABOUT THE ACCIDENT. WAS JOEY ON THE PHONE UP UNTIL THE INCIDENT. OR HAD THE INCIDENT ALREADY OCCURRED

2. WHERE WAS JOEY WHEN HE MADE THE CALL. WERE COULD HE BE FOR THE KINGSTON ROAD TOWER TO PICK HIM UP. IS THIS THE TOWER THAT TOOK THE CALL OR IS IT ONE OF A SERIES OF TOWERS TO LINK HIM TO HIS CALL

7:21-JOEY CALLED HIS FATHERS RESIDENCE. THIS WAS ALMOST AS SOON AS HE HUNG UP FROM TALKING TO THE GIRL IN CEDARTOWN. THIS CALL ONLY LASTED 43 SECONDS.

QUESTIONS TO BE ANSWERED

1. WHY WOULD JOEY CALL HIS HOUSE IF HE HAD JUST LEFT THE HOUSE.

2. WHY DID JOEY ONLY STAY ON 43 SECONDS

3. IN HIS STATEMENT TO MIKE KEY JOEY TOLD MIKE HE DIDNT LEAVE HIS HOUSE UNTIL 7:20. IF HE LEFT HIS HOUSE AT 7:20 (THE EXACT TIME OF THE INCIDENT) HOW AND WHY WAS HE ON THE CELL PHONE CALLING HIS DAD AT 7:21 AND HIS GIRLFRIEND AT 7:15. THIS CALL WAS HANDLED BY THE ROME TOWER. WHERE DID THEY SWITCH AND WHERE WAS HE WHEN HE MADE THE CALL.

7:22- JOEY CALLED HIS GRANDMOTHERS HOUSE. TALKED FOR 1 MINUTE AND FOURTEEN SECONDS. THIS CALL WAS ON THE ROME TOWER.

QUESTION: WHERE WAS HE AND WHY DID HE CALL HIS GRANDMOTHERS HOUSE

7:23 JOEY CALLED HIS UNCLE AT THE PITTSTOP IN GAYLESVILLE ALABAMA THE CALL ONLY LASTED 25 SECONDS AND WAS FROM THE TURNER MCCALL TOWER

QUESTION: WHY DID HE CALL HIM AND WHERE WAS HE WHEN HE CALLED. DID HE NOT REACH HIM, THE CALL ONLY LASTED 25 SECONDS.

7:27 JOEY CALLED HIS HOME AGAIN. THIS TIME THE CALL LASTED 1 MIN AND 7 SECONDS. THIS CALL WAS ALSO FROM THE ROME TOWER.

QUESTIONS

1. WHY WAS JOEY ALL OF A SUDDEN MAKING THESE PHONE CALLS ONE RIGHT AFTER THE OTHER.
2. WHY WAS HE MAKING TWO CALLS TO HIS HOUSE AT 7:21 AND AT 7:27 IF HE HAD JUST LEFT THE HOUSE.
3. WHY WAS JOEY CALLING HIS UNCLES SHOP IN ALABAMA. HE TOLD MIKE KEY THAT HE HAD BEEN FISHING ALL DAY WITH HIS UNCLE IN ALABAMA AND DIDNT GET HOME TILL AFTER SEVEN
4. IN HIS STATEMENT TO MIKE KEY JOEY TOLD MIKE THAT HE CALLED HIS SISTER TO TELL HER HE SAW ISAAC WRECKED ON THE SIDE OF THE ROAD. HE TOLD MIKE KEY THAT HE WAS STOPPED IN THE TRAFFIC AND A POLICE OFFICER WAS WORKING TRAFFIC AND ONLY ONE LANE WAS OPEN. THE TWO CALLS JOEY MADE TO HIS HOUSE WAS AT 7:21 AND AT 7:27. JOEY ALSO SAID THAT THE AMBULANCE PASSED HIM GOING TO THE SCENE. THE AMBULANCE DIDNT ARRIVE ON THE SCENE TILL 7:26. THE POLICE WERE ON THE SCENE AT 7:22. THE FIRST CALL TO HIS HOUSE TO TELL HIS SISTER THAT ISSAC WAS IN A WRECK COULDN'T HAVE HAPPENED BECAUSE THE POLICE HAD NOT ARRIVED AT THE SCENE YET. THE SECOND CALL AT 7:27 COULD HAVE BEEN THE ONE WHERE HE TOLD HIS SISTER, BUT THE AMBULANCE WAS JUST GETTING ON THE SCENE AND THE POLICE HAD JUST BEEN THERE LESS THAN 5 MINUTES. COULD THEY HAVE SHUT DOWN THE LANES IN THAT LENGHT OF TIME OR DID JOEY MAKE TWO TRIPS DOWN THAT ROAD. TIMING IS JUST TO TIGHT.

7:35. JOEY CALLS HIS GIRLFRIEND IN CEDARTOWN. THIS CALL ON THE CEDARTOWN TOWER. JOEYS GIRLFRIEND STATES THAT JOEY NEVER MENTIONED THE ACCIDENT. JOEY IN HIS STATEMENT SAYS THAT HE DIDNT TELL HER ABOUT IT BECAUSE SHE DIDNT KNOW ISAC AND IT WOULDNT MEAN ANY THING TO HER.

QUESTION

1. WHETHER THE GIRLFRIEND KNEW ISSAC OR NOT. WOULDNT SOMEONE TALK ABOUT THE WRECK AND THE POLICE AND AMBULANCES
2. SOMEWHERE IT HAS BEEN SAID THAT, JOEY CONSTANTLY TALKED ABOUT ISSAC AND BRIANNE TO THE GIRLFRIEND IN CEDARTOWN. WE NEED THIS VERIFIED.
3. DIDNT JOEY TELL SOMEONE THAT HE MADE TWO TRIPS PAST THE ACCIDENT? IF SO WHO DID HE TELL THAT TWO. THIS IS IMPORTANT
4. JOEY HAD A CELL PHONE WHY DID HE NOT CALL ANYONE ELSE ABOUT THE ACCIDENT?
5. JOEY SAID HE LEFT ALABAMA AT 6:30 OR 6:45. HOW DID HE GET TO ROME, GO TO HIS HOUSE SHOWER, MAKE A PHONE CALL, ACCEPT ANOTHER AND STILL

HAVE THE TIME TO BE MAKING CALLS AT 7:15 ON HIS CELL PHONE OFF THE KINGSTON TOWER. WE HAVE TO TALK TO THIS UNCLE.

6. IN A SECOND INTERVIEW WITH JOEY MIKE KEY ASKED JOEY WHAT HE DID THE DAY FOLLOWING THE SHOOTING OF ISSAC. JOEY TOLD HIM HE HAD GOTTEN UP EARLY AND HAD GONE FISHING AND THAT HE WAS GONE ALL DAY. CELL PHONE RECORDS SHOW THAT JOEY WAS AROUND ROME MAKING PHONE CALLS ON HIS CELLPHONE

FIND THE PEOPLE HE CALLED

JOSH FLEMISTER- TALKED WITH SAMATHA DAWKINS AND TOLD HER HE WAS WITH JOEY WHEN HE WENT TO CEDARTOWN ON THE NIGHT OF ISACS DEATH. WHY DID HE TELL HER THAT. GIRLFRIEND AND HER PARENTS SAY THAT JOEY WAS ALONE WHEN HE GOT THERE.
HAVE TO PICK UP JOSH FLEMISTER

PAUL- SAMATHA DAWKINS EX BOYFRIEND. ASHLYN (CEDARTOWN GIRLFRIEND OF JOEY TOLD JIM FREE THAT JOEY HAD SAID THAT PAUL KILLED ISSAC.
PICK UP PAUL

COREY JACOBS

TOLD STANLEY SUTTON THAT HE HEARD JOEY ON THE HOME DEPOT TALKING TO A GROUP OF PEOPLE. JOEY WAS TELLING THE PEOPLE THAT HE WATCHED ISSAC GET INTO THE CAR AT FLOYD JR. COLLEGE AND THEN HE FOLLOWED HIM. ISSAC SAID THEY PULLED HIM OVER AND "BOONIE " SHOT HIM. SAYS SHOT AT HIM TWICE.

FIND OUT WHO HAS THE STREET NAME BOONIE. IF IT IS THE ONE IN JAIL THEN WE ARE IN BUSINESS.

FIND OUT FOR SURE IF THE CITY PICKED UP TWO CASINGS FOR THE BULLETS. ONLY COREY AND THE MAN IN JAIL HAS SAID TWO SHOTS WERE FIRED. I DONT THINK THE CITY EVER RELEASED THAT THERE MIGHT HAVE BEEN TWO SHOTS FIRED.

TRY TO FIND OUT WHO ELSE WAS IN THAT CROWD JOEY WAS TALKING TO

DANA GARRETT

TOLD SGT. SUTTON THAT SHE AND BRANDY MAYNARD WERE RIDING AROUND AND THEY HEARD SOMETHING OVER THAT NEWS ABOUT THE DEATH OF ISSAC DAWKINS. BRANDY MAYNARD TOLD DANA THAT HER BROTHER SHANE MAYNARD HAD TOLD HER THAT JOEY AND SOME OTHER DUDE WERE SUPPOSE TO BE FIGHTING ISSAC OVER BRIANE AND THAT THEY PULLED HIM OVER AND SOMTHING HAPPENED AND THEY ENDED UP SHOOTING DAWKINS. SHE SAID THAT SHANE HAD TOLD HER THAT IT WAS JOEY THAT SHOT HIM BUT SOME

OTHER MAN WHO THEY COULNNT NAME THAT HAD DONE THE ACUTAL SHOOTING, THIS IS ONLY THE SECOND TIME ANOTHER NAME HAS COME UP THAT ACUTALLY DID THE SHOOTING. THE OTHER TIME WAS FROM OUR MAN IN JAIL

NEED TO FIND AND BRING IN BRANDY AND SHANE MAYNARD. SHANE SEEMS TO HAVE BEEN TOLD DIRECTLY BY JOEY. THIS ALL GOES ALONG WITH OUR MAN IN JAIL.

CHAD REDDEN

TOLD SGT. SUTTON THAT ISSAC HAD FOUGHT JOEY BEFORE IN THE DRIVEWAY OF JOEYS HOUSE. HE ALSO STATED THAT HE. CHAD ALSO HAD WITNESSED JOEY PULLING A GUN ON DELANE ROACH BECAUSE DELANE HAD TAKEN BRIANNE OUT ON A DATE. THIS HAPPENED AT THE MALL. HE ALSO MENTIONED THAT JOEY HAD SHOT AT DELANE AT HIS HOUSE (JOEYS HOUSE). CHAD ALSO STATED THAT JOEY HAD THREATEND HIM SEVERAL TIMES.
