HERE IS A QUICK, GENERAL OVERVIEW OF THE EVENTS SURROUNDING THE ATTEMPT TO TALK WITH JOEY AFTER THE JAN. 11TH INCIDENTS.

AS YOU KNOW, ROME POLICE OFFICERS MIKE TAYLOR AND HANK JACKSON WERE DISPATCHED TO A ACCIDENT WITH INJURIES LOCATED ON Hwy. 27 SOUTH NEAR ALCAN.

THIS OCCURRED AT 1920 HOURS AND THE OFFICERS ARRIVED AT 1922 HRS.

THE INITIAL INDICATION WAS THAT THE WRUCC WAS JUST THAT, A BAD ACCIDENT. IT WAS NOT UNTIL APPROXIMATELY 9 PM OR 1-11:00 THAT A BULLET FRAGMENT WAS DISCOVERED IN THE HEAD OF ISAAC DAWKINS.

AT APPROXIMATELY 9¹⁰ PM, I WAS NOTIFIED OF THE FINDINGS AT EUC AND UPON ARRIVAL AT FLOYD MEDICAL, DR. ^{JILL} CHAIR HEAD AND NEUROLOGIST DR. CARL HERRING, WERE ATTENDING TO ISAAC DAWKINS.

THE ACCIDENT SCENE WAS SECURED, MARSHALL ARRIVED AT THE ACCIDENT SCENE AND DISCOVERED THE BULLET HOLE IN THE REAR, SLIDING GLASS ~~OR~~ WINDOW OF ISAAC'S TRUCK AND I LATER MET WITH FAMILY AND FRIENDS.

DURING THE COURSE OF TALKING WITH FRIENDS AT FLOYD, INFORMATION WAS GATHERED THAT JOEY WATKINS AROSE AS A POSSIBLE SUSPECT DUE TO PAST ALLEGED PROBLEMS BETWEEN ISAAC & JOEY. THESE PROBLEMS INCLUDED VERBAL CONFRONTATIONS, A 1 TIME PHYSICAL ALTERCATION AND WHEREAS JOEY ALLEGEDLY SHOT ISAAC'S

ON 1-12-00 AT 4³⁵ PM, MYSELF AND LAMAR
CLARK WENT TO 28 PARKWOOD CIRCLE WHERE I MET
FOR THE 1ST TIME TANDI WATKINS.

TANDI STATED JOEY WAS NOT THERE THAT
HE WAS OUT ON HIS MOTORCYCLE. A WHITE DODGE
DAKOTA PICKUP TRUCK AND A 4 DOOR GREENISH, BLUE
COLORED PONTIAC, SMALL CAR, WERE IN THE DRIVEWAY.

I LEFT MY CARD AND ASKED TANDI TO
TELL JOEY TO CALL ME WHICH HE DID LATER
ON JAN. 12TH. A INTERVIEW WAS SCHEDULED
FOR 8:30 ON JAN 13TH.

AT APPROXIMATELY 9⁵⁰ AM ON JAN 13TH,
JOHNNY WATKINS CALLED ME AND SAID JOEY
WOULD NOT BE COMING IN TO TALK TO ME.

I EXPLAINED MY INTENTIONS FOR THE
INTERVIEW BUT JOHNNY SAID THAT DUE TO ME
GOING TO HIS HOME, QUESTIONING TANDI ABOUT WHO
DRIVER WAS VEHICLE AND THAT BECAUSE MIKE KEY
OR MARSHALL DID NOT CALL HIM, BILL O'DELL NEEDED
TO BE PRESENT AND JOEY WAS NOT COMING IN.

JOHNNY WATKINS ALSO STATED THAT JOEY
COULD NOT HAVE DONE THAT, SHOOTING, ANYWAY
BECAUSE JOEY WAS AT HOME WITH HIM ALL
NIGHT ALONG WITH THREE OTHERS.

I SAID SOMETHING TO THE EFFECT OF; SO
YOU'RE SAYING JOEY WAS AT HOME WITH YOU, YOUR
