Subject heard from an unknown person that Joey had told Breann Scarber that he had shot Mr. Dawkins dog.

Subject stated that she heard Jeff Blankenship, her husband, that Joey had hit Breann at a mall around Christmas time.

Her husband works at Annacher High school.

subject, on the night Mr. Dawkins was shot, was ~~on the phone~~ talking with Kim Weatherby (Senior at Coosa) and she said that Joey Watkins and Mr. Dawkins had been in fight's before over Breanne Seaver.

Manica Daves when at the hospital, was told by an unknown person that on several occasions that Joey Watkins had tried to run Mr. Dawkins off the roadway.

subject heard from Manica Daves that Joey Watkins had also shot Mr. Dawkins dog.

subject spoke with Jenny Hauman, who is friends with Joey Watkins sister, and she said that Jerry Paul Allen's truck (Paul was a friend of Joey's) was seen in the area where Mr. Dawkins was shot. This was, according to Jenny Hauman, right after Mr. Dawkins was shot.

According to the subject, Paul Allen, along with Joey Watkins, and Mr. Dawkins had all dated the same girl. According to the subject Joey and Paul were friends and they had never fought about the girl.

Subject stated that on several occasions that she heard Paul was in the suspect vehicle the night Mr. Dawkins was shot. Jenny Harmon also told the subject that Paul was in the vehicle.

Subject stated that Paul Allen is driving a truck. She's not sure ~~it~~ of the color, make or model. She also stated that Mr. Allen used to drive a passenger vehicle.

According to the subject, Tim Hughes also was in an ongoing feud with Mr. Dawkins. Mr. Hughes had dated Samantha Dawkins and Mr. Dawkins disliked Tim for how he treated his sister. According to the subject Tim Hughes was still dating Samantha at the time of the murder. The subject

stated that she has seen Tim get into several fights, many of which Tim has become violent.

Last summer, the subject stated that Adam Elliot was riding with Joey Watkins in Joey's car and Joey had a gun. Subject stated that Adam told her Joey showed him a gun. For Adam immediately got out of the vehicle to avoid any trouble.
