30 DJ: You ready dog?

31 Mother: Shit.

32 CJ: You are.

33 Mother: You coming in?

34 DJ: My shit -(inaudible) in the back.

35 CJ: Yeah.

36 Mother: You coming in David?

37 DJ: Do what?

38 Mother: You coming in tonight? Judy bought Paul pair a Timberlands today didn't give
39 but \$89.00 for 'em.

40 DJ: I love you.

41 Mother: Love you.

42 DJ: No I don't know if I - I might stay over there --

43 Mother: Up where?

44 DJ: going on -- I don't know now, I kind - I don't really know 'til I know so I know --

45 Mother: Call me. I'm on tell you some'em now you better not go off, driving and drinking
46 (inaudible).
47 DJ: Alright, well I love you.
48 CJ: Bye Joanne.
49 Mother: Bye, hey ya'll be careful - hey ya'll if you find any Somas let me know 'cause I'd
50 like to have 'bout ten of 'em.
51 CJ: Okay.
52 Mother: Alright.
53 CJ: Alright.
54 Mother: Alright, ya'll be careful.
55 DJ: Uh-oh.
56 CJ: Oh, -- down-- (singing) Hey you know who uh, (inaudible) is?
57 DJ: Who?
58 CJ: What was that nigger's name we saw at Governor's the other day?
59 DJ: Mark Free.
60 CJ: Yeah. Like that Deli nigger -- I got Deli and (inaudible)
61 DJ: Damn Corey, you (inaudible)
62 CJ: What?
63 DJ: That's 'cause (inaudible) I wish it was teen night.
64 CJ: Where's at Governor's?
65 DJ: -- (inaudible) mother fucker up. You hungry?
66 CJ: Yeah.

67 DJ: I'm mother fucking hungry too dog.

68 CJ: When did you get outta jail?

69 DJ: On a Monday.

70 CJ: Was Mark in there with you or some'em?

71 DJ: Yeah.

72 CJ: Was ya'll -- was ya'll cell mates with Mark?

73 DJ: He was in the same dorm but not the same room.

74 CJ: Oh.

75 DJ: You been to the back before hadn't you? Been to the back?

76 CJ: Yeah. How's that mother fucker know who done that shit about Joey and them?

77 DJ: I don't know - I don't - I don't really care who did - I don't - you know how I am.

78 CJ: I heard somebody talking about that shit other day, 'at reward's like \$15,000.00.

79 DJ: Yeah, it's on the damn stores man, all the doors. At Robbins, you know down

80 there at Robbins by my gradmaw's --

81 CJ: Yeah.

82 DJ: It's on that door.

83 CJ: You told me he was there you know.

84 DJ: He said he was. I don't know I ain't getting in this shit --

85 CJ: Turn him in and get paid. You wouldn't wanna get paid for it?

86 DJ: Yeah but I ain't no narc, you know what I'm saying, unless it just comes downs to

87 it -- fifteen dollars cash -- fifteen thousand cash in my hand - Mark Free was there.

88 CJ: Was he there, no seriously.

99 DJ: Yeah, that's what he said.

100 CJ: That's what he said. I ain't lying nigger alright I ain't gone say nothing unless
101 you wanna say some'em - shit I ain't scared I don't know them mother fuckers.

102 DJ: Oh I ain't scared neither.

103 CJ: Cause he - he said somebody was trying to snitch on his ass anyway wouldn't he?

104 DJ: No, (inaudible)

105 CJ: Fired who?

106 DJ: (Inaudible)

107 CJ: How many people was up there?

108 DJ: I don't know I didn't ask him all that ---

109 CJ: See 'cause Josh heard some'em 'bout that shit too -- about Mark, 'cause he uh, he
110 even ask me he said Stanley looking for me the other day when we was down at Chili's.

101 DJ: Yeah.

102 CJ: and uh, told 'em I was with you and shit. Hey went up there man he

103 DJ: Never mind, I'm hungry as shit dog I'm on go in here and tear this mother fucker
104 down.

105 CJ: I ain't lying may I don't see - I want to know how you really feel about getting
106 paid -- I thought about that man when he said that I got thinking about that reward, I thought
107 Hell no - you know what ---

108 DJ: I mean nigger I'd like to get paid -- I want get me a (inaudible)

109 CJ: I mean I'm your boy man if you know some'em you know you better let me know.

110 DJ: Yeah he said he was there. He knows you ain't gone tell.

111 CJ: I mean like with 'em when they shot his ass?

112 DJ: (Inaudible)

113 CJ: But I ain't lying man - did you know him, Isaac?

114 DJ: Uh-uh, did you?

115 CJ: Little bit.

116 DJ: (Inaudible)

117 CJ: Yeah, he didn't deserve to die man - I mean a lot a people in this world you know

118 do shit, get killed over some stupid shit but that was over a bitch.

119 DJ: Don't fight over no bitch unless it's damn worth it -- not kill the mother fucker,

120 knuckle up to 'em - know what I mean.

121 CJ: When did he tell you he was there though?

122 DJ: (Inaudible) (Background noises) W'e just fucked up (inaudible) in jail talking --

123 some how it got brought up.

124 CJ: I ain't lying but I'm on get paid, you - are you with me on it?

125 DJ: I'll tell you all the information you can just go get the money.

126 CJ: Alright let let - let's talk dude.

127 DJ: He said that Joey shot him and they was there -- they took off, he said --

128 CJ: Joey shot him?

129 DJ: Yeah.

130 CJ: Joey's a bitch. I just can't see that little skinny mother fucker shooting somebody.

131 DJ: I don't even know him - I don't care to know -- you ain't my home boy fuck you.

132 CJ: I heard that Joey was just fucking driving.

123 DJ: Said Joey shot him.

124 CJ: He said Joey shot him.

136 CJ: Told you this (inaudible)

137 DJ: Damn, man I'm glad I ain't got nothing on me. That mother fucker (inaudible)

138 CJ: That shit didn't (inaudible) that shit anyway.

139 DJ: But I just been paranoid - that one there.

140 CJ: Let's go in this mother fucking grub. (Inaudible) But Mark Free told you that --

141 I ain't lying man I don't know the mother fucker I'll go tell. He told you that shit in jail though.

142 DJ: Uh, he said --

143 CJ: Who was driving, did he say who was driving?

4 DJ: Uh-uh, he said he's in the back fucked up.

145 CJ: But wouldn't they - was they in Joey's truck?

146 DJ: Ever -- I never - I didn't go into details you know what I'm saying.

147 CJ: Man why don't get this nigger come around us - did he ever call you?

148 DJ: Who Mark?

149 CJ: Yeah.

150 DJ: Nah-uh, he'll call though.

151 CJ: He will?

152 DJ: Yeah. If this mother fucker ain't hitting we going some where else.

153 CJ: Man this is (inaudible) Two smoking.

154 DJ: (Inaudible) is bum fucked man.

155 CJ: Nah, you think you can get that mother fucker to call us --

156 DJ: I know I can, I can (inaudible)

157 CJ: Bullshit.

158 DJ: Let's go some where else and eat.

159 CJ: Nah.

160 DJ: This mother fucker ain't hitting dog--

161 CJ: Man you are (inaudible)

162 DJ: Man I'm trying to tell you I know it's hitting, let's go.

163 CJ: Where?

164 DJ: At uh, the Mexican restaurant we went to the other night - they serve better and

165 shit.

166 CJ: You done lost your mind man.

167 DJ: Come on dog.

168 CJ: Ah, you gotta (inaudible)

169 DJ: Alright - can we get some uh,

170 CJ: cheese --

171 DJ: cheese --

172 Unk: Cheese dip?

173 DJ: Yeah.

174 CJ: (Inaudible) right here too- nachos and beef, no onions.

175 Background noise too loud - (inaudible.)

176 DJ: That's what setting us up - man - that smoking shit --

177 CJ: Now I tell you what, if you could get in touch with Mark, (inaudible) huh, I
178 wouldn't care, I (inaudible) get around him (inaudible)

179 DJ: Do what?

180 CJ: I'll go on to court.

181 DJ: You'll go through the court and tell on him.

182 CJ: Yeah.

183 DJ: On \$15,000.00. (Inaudible) -- fifteen thousand you know - I --

184 CJ: I'll split it with --that's 750 a piece. \$7,500.00.

185 DJ: That get us a motorcycle dog--

186 CJ: That's bad. I mean it ain't gone get you no Harley or no shit.

187 DJ: You're right. --let's go eat at Hooters.

188 CJ: Fuck that, (inaudible)

189 DJ: That's what's good about it. (Inaudible)

190 CJ: Man (inaudible)

191 DJ: Tell 'em we're ready to order.

192 CJ: You know they (inaudible) Joey and (inaudible) said about that?

193 DJ: He got arrested for it -- they bonded.

194 CJ: Well you my boy and if wanna talk to mother fucker (inaudible) see that's up to
195 you I don't (inaudible)

196 DJ: (Inaudible) Is he trying tell on you?

197 CJ: Nah, he said they they were all a bunch a pussys. I bet them mother fuckers are
198 playing hard 'cause they shot somebody.

201 CJ: Hum?

202 DJ: Huh?

203 CJ: Yeah.

204 DJ: Did you tell her you's (inaudible)

205 CJ: I probably (inaudible) fucker came in here.

206 DJ: Tell your mamma hang around with boys.

207 CJ: (Inaudible) --

208 Background noise too loud

209 DJ: Never, we ain't never done nothing wrong, we just got a - stole a Mickey Mouse

10 hat.

211 CJ: (Inaudible)

212 DJ: Huh?

213 CJ: That was some shit. Your mamma hated me a long time for that shit.

214 Background noise too loud.

215 DJ: (Inaudible) - that's what we need --we need to be in the smoking section.

216 CJ: That's what I was at.

217 DJ: Smoking - I'm on fire up a cigarette - don't think I won't.

218 CJ: (Inaudible)

219 Background noise too loud.

220 CJ: Can he be arrested for it -- anything about that murder case?

221 DJ: No.

222 CJ: Even assessor?

223 DJ: Yeah he's under surveillance now -- investigation, whatever you wanna call it.

224 CJ: You know he trust you enough to talk to you?

225 DJ: Don't see why he wouldn't -- he already has. Yeah I want some um - I want

226 some nachos and beef --

227 Waiter: Nachos --

228 DJ: and beef -- nachos and beef and no onions, no tomatoes or none of that - just

229 nachos and beef and cheese. You want the same thing. I want tea.

230 CJ: I want a Dr. Pepper. Huh?

231 DJ: Yeah.

232 Waiter: (inaudible)

233 DJ: Yeah, let me have (inaudible) - I'm on step out up here and smoke.

234 CJ: Alright.

235 DJ: And go to the bathroom (inaudible)

236 CJ: You wouldn't talk to a detective David?

237 DJ: I wouldn't talk to 'em unless they gave me \$15,000.00.

238 CJ: Man you have to. I know this much, there has to be an arrest and a conviction

239 before you get the money. So if you help them - I mean if you told 'em who done it, and could

240 prove who done it - I mean he -- he probably wouldn't say nothing to you around me 'oh would

241 he?

242 DJ: It's all a bunch a pussys man, that's all it is.

243 CJ: I know.

244 DJ: I had to take up for him in jail one or two times.

245 CJ: Who, Mark?

246 DJ: Yeah.

247 CJ: Somebody trying (inaudible)

248 DJ: Somebody tried to steal some shit out a his box.

249 CJ: What his underwear and sox and shit?

250 DJ: No his food.

251 CJ: Oh.

252 DJ: I went and told him, he said oh man what am I gonna do - I said there's only one

253 thing to do -- I said I got your back he said no man they can just have it - I said no man,

254 (inaudible) said look man ya'll gone have to give his shit back.

255 CJ: They niggers?

256 DJ: Yeah, you can just stay out a this, what they said -- I said well normally I would

257 but I've known this boy a long time and you gone give his shit back. And I knew the boy that

258 took the shit - I told him, I said look you know what I'm saying, I said we can work some'em out

259 - I said Hell give him some his shit back you know what I mean - I said nigger gotta eat, you

260 know what I mean -- then he gave him some his shit back - he didn't give all of it back to him

261 though.

262 CJ: You gone have to beat my ass get my shit.

263 DJ: That's how I was when I'd wake up - first thing you'd hear was me and Earl.

264 CJ: You and who?

265 DJ: Earl, that's a true mother fucker right there dog.

266 CJ: Man the only thing about that - Mark's ass on that intensive probation and shit.

267 Is he working any where or anything or do you know?

268 DJ: He said he was working - (inaudible) you ain't wired are you?

269 CJ: No.

270 DJ: This shit --

271 CJ: You know - I would be with him though.

272 DJ: Huh?

273 CJ: I would be if I could talk to his ass.

274 Background Noise too loud - inaudible

275 CJ: Man he come up to me trying to kill me like -- when you pull up behind me trying

276 to blast me in my car now you just well--

277 DJ: I'm on slam on the brakes.

278 CJ: I hear you.

279 DJ: Eat your ass. You better sh-- I'm on make sure you shoot me - I'm on crawl

280 through a window or some'em.

281 CJ: Ah yeah them mother fucker all just (inaudible) you.

282 DJ: Huh?

283 CJ: How the Hell they gone have us killed (inaudible)

284 DJ: Don't think I couldn't - don't think I couldn't.

285 CJ: Same way I'd (inaudible)

286 DJ: Huh?

287 CJ: (Inaudible)

288 DJ: I - I - I can't help it mother fucker killed their boy -- who could? Huh?

289 CJ: I mean like outside jail?

290 DJ: I'm saying yeah I would if I was in jail and --

291 CJ: And just say I was --

292 DJ: (Inaudible) kill me - I can have you killed -- you may not believe (inaudible) but I -

293 I - I can do this (inaudible) my family's true - be blood for blood you know what I mean. That's

294 all (inaudible) - if you was in jail and you wanted me go whoop somebody's ass I would you

295 known what I'm saying.

297 CJ: I hear you.

298 DJ: 'Cause it was just billshit, I just wouldn't have it.

299 CJ: We outta chips and dip - they need to come on.

300 DJ: Yeah.

301 CJ: No man --

302 DJ: Hey where's the rest room.

303 CJ: Huh?

304 DJ: (Inaudible)

305 Background noise too loud, inaudible)

306 CJ: Oh, oh yeah (inaudible) -- that black vest on?

307 DJ: No, that damn --

308 CJ: They (inaudible) us.

309 DJ: They must a mother fucking (inaudible)
10 CJ: Tell me - they'll fix it - don't touch it --
311 DJ: Huh.
312 CJ: No.
313 DJ: You didn't get no onions?
314 CJ: Yeah.
315 DJ: I'm eating I'm starved.
316 CJ: Man I don't feel like picking through this shit. Man all I'm trying do is help us
317 get paid. 'Cause when you said that shit about him being there and shit man I's like what are
318 you -- I mean wouldn't you want some'em done if somebody killed (inaudible) and Chris?
319 (Inaudible) or whatever. (Inaudible)
320 DJ: Nah man it's like this, okay you go to jail, I go to jail with you - you know what
321 I'm saying, 'cause I'm gone get 'em myself regardless - you know what I mean, if I have to go to
322 jail for it - I get moved out of every mother fucking block just to catch that one mother fucker.
323 See this shit (inaudible) -
324 CJ: Man if I (inaudible) -- if he blows, we'll come in here eat them damn chips all
325 damn night--
326 DJ: Ha-ha.
327 CJ: cheap as Hell.
328 Background noise too loud, inaudible
329 CJ: I mean they only cost like a dollar fifty or some shit.
330 DJ: If you don't order nothin' else?

331 CJ: Yeah.

332 DJ: They're free other than that ain't they?

333 CJ: Then they give you more after what you buy -- and (inaudible) drink.

334 DJ: I thought they was damn free.

335 CJ: What?

336 DJ: Nachos. (Inaudible)

337 CJ: No serious, what's your opinion on getting paid?

338 DJ: I ain't gone lie to you man --

339 CJ: You down --

340 DJ: I'm down for money. I hit the mother fucker - I hit that police officer somebody

341 gone give me \$10,000.00 right there - (inaudible) Give the money to you and I can have it when

342 I get outta jail in three months. You wouldn't hit a police officer for \$10,000.00 cash? Huh?

343 CJ: Probably.

344 DJ: I mean would you do three months for \$10,000.00?

345 CJ: Fuck yeah. Why, you do three months for hitting a cop?

346 DJ: Huh?

347 CJ: You get three months for hitting a cop?

348 DJ: That's just all that's left on my probation.

349 CJ: Be like Hell when I got out. I really would.

350 DJ: Do what?

351 CJ: I really would love to smack that uh, city cop - if I knew I wouldn't go to jail

352 (inaudible) I mean I hate the city cops.

353 DJ: Yeah I hate the city cops, that one dude, he's (inaudible)

54 CJ: That dude with a normal shirt on.

355 DJ: We passed him - I seen him in court when I was going to court. What this shit

356 gone be --

357 CJ: I don't know, (inaudible) Man you done wiped it out ain't -- Your thing - you

358 paying?

359 Waiter: You pay.

360 CJ: I ain't got no money

361 DJ: You paying?

362 CJ: Yeah.

363 DJ: Huh?

364 CJ: Yeah.

365 DJ: You gone pay for both of us?

366 CJ: Um-hum.

367 DJ: You serious?

368 CJ: Yeah, man you - you (inaudible) the other day.

369 DJ: Good (inaudible) now I won't be broke --(inaudible) \$99.00 --

370 CJ: Hey man you better wait till you be rich.

371 DJ: (Inaudible)

372 CJ: (Inaudible) We ain't scared. Did you hear about Buddy Vines popping Joey's

373 ass in the mall?

374 DJ: Yeah he told me about that too, he said if Mark Fre-- Mark said he jumped on --

375 some'em 'bout Mark on Buddy and Buddy didn't fight him. Got a light off bathroom.

376 Background: (inaudible)

377 DJ: On this side? I heard about it - but I didn't you know what I'm saying, I heard his
378 story.

379 CJ: He's gone right now.

380 DJ: You'll never guess who's here.

381 CJ: Who?

382 DJ: (Inaudible)

383 CJ: Hell no, you gotta be bullshitting me.

384 DJ: It was 'bout three plates on the table is dog.

385 CJ: She's gotta be by herself.

386 DJ: Nah, she's with some girl.

387 CJ: Nah, Joey squirled Buddy's ass.

388 DJ: (Inaudible) I don't know I ain't - you know what I'm saying I heard his side of
389 the story -- he said that um, - you say what now, what happened?

390 CJ: I heard that Joey squirled Buddy.

391 DJ: (Inaudible) what I heard,

392 CJ: And then later on or some'em he - Buddy popped his ass and Joey went and took
393 out a warrant on him.

394 DJ: This is what I heard - so and so and so and so - and uh, (inaudible) Buddy and him
395 got into it -- Buddy and uh, Joey got into a fight and Mark was out there while Joey and
396 somebody else was fussing, with her - Buddy and uh, Lark, he said that Buddy run from him.

397 You know what I'm saying - Buddy ain't no - everybody thinks he's a bad ass but I know he
398 wouldn't run - I told him that - you know what I'm saying, Buddy'll fight, you know that -
399 Buddy'll fight. I's like, I mean you know what I'm saying he ain't as hard as everybody thinks

408 CJ: Look man I wanna know seriously, will you go up there and talk with 'em. I'm
409 ser-- I'm dead serious. That's what Im getting right there.

410 DJ: Huh?

411 CJ: That's what I'm getting -- nah, that's what Dustin drives and I'm getting his truck.

412 DJ: It ain't like that though.

413 CJ: Yeah it is.

414 DJ: It's lit up like 'at and everything.

415 CJ: I don't think the tires are that big.

416 DJ: Is it tight like that?

417 CJ: It's tight, I don't know if 'em tires are 'at big. Man his is --

418 DJ: --tha car is sweet ain't it.

419 CJ: it's right -- it's black, jet black with tinted windows.
20 DJ: You fixin' get it?
421 CJ: Huh? I'm serious man - I know who we can go talk to?
422 DJ: Who? Stanley? Nigger what the fuck?
423 CJ: Man Stanley's cool and shit though you tell him.
424 DJ: Stanley a bitch ass police man.
425 CJ: Hell they all police.
426 DJ: I know.
427 CJ: Well where in the fuck we gotta go?
428 DJ: We gone cruise through town nigger, find some pussy.
429 CJ: Want no pussy -- you lite me a cigarette. Seriously man, go up there with me -
30 we go up there right now.
-31 DJ: Huh, God damn, I'm trying to get fucked up tonight and you trying get me go talk
432 to the police.
433 CJ: Come on dog 'cause you my boy man - for real.
434 DJ: What the Hell's wrong with you man.
435 CJ: Come on.
436 DJ: I - I - damn nigger.
437 CJ: No we can go do whatever we want to when you get done.
438 DJ: Ha-ha do what?
439 CJ: Nigger, you suppose to be my boy, what the fuck you doing - get off me --
440 DJ: You wired ain't ye?

441 CJ: No, why would I do some shit like that?
442 DJ: Let me see.
443 CJ: Huh?
444 DJ: Let me see.
445 CJ: Let you see.
446 DJ: Ha-ha, let me see -- ha-ha.
447 CJ: I can't even believe you ask me some shit - hey I can't even believe you as-- get
448 off me now - I can't even believe you ask me a question like that -- why would I do some shit like
449 that - I mean I ain't - this ain't Mark Free - I want talk to you - I mean I will - I tell you this, it - it
450 has been discussed but we got to get that mother fucker to talk - but I was gone talk to you
451 before --
452 DJ: What's Stanley doing?
453 CJ: About talking to Mark Free.
454 DJ: What, does Stanley wants us --
455 CJ: Yes, 'cause I mean - 'cause they - they --
456 DJ: He's wanting me to tell --
457 CJ: they come got me a couple months ago because me and Joey was gone fight one
458 time and his bitch ass wouldn't fight.
459 DJ: Know what I'm saying - I don't - I don't know - you gotta let me think on some

465 DJ: (Inaudible) -- we'll talk about it later man, I don't wanna hear that bullshit.

467 DJ: I ain't gonna - I ain't gonna - I ain't no damn narc --

468 CJ: Neither am I but I'm just saying - I mean, Stanley was talking to Buck about it and

469 me too - you know I remembered you telling me about that mother fucker saying some'em 'bout

470 being there.

471 DJ: (Inaudible)

472 CJ: You know, I mean Stanley was just telling Pug that - you that he, you know he

473 handled a lot a cases you know but ain't none of 'em bothered him like this because that boy

74 didn't have no reason to die - you know he was like, well look at it like this, what if somebody

→75 killed (inaudible) -- you know mother fucker killed my brother then you got your (inaudible) to

476 worry about. You know and I didn't tell - I didn't say no names, I didn't say nothin, I just said--

477 DJ: I - I mean I --

478 CJ: I can probably get to this - I can probably get to the bottom of this you know if

479 this person helps. No, I'm not wired and no it's not anything I just wanted to talk to you about

480 it. This mother fucker gone ask me if I'm wired. (Inaudible) and he gone ask me question like

481 this.

482 DJ: I mean you know what I'm saying, it ain't the point that I wouldn't tell - it's the

483 point that I can't tell and it - if I did tell it wouldn't gone help in court 'cause I'm on probation --

484 and when your under probation they put your mother fucker down uh, being a narc and shit.

485 CJ: Shit, nigger that might help you get off probation.

86 DJ: Only way I talk 15 cash and damn get me all the trouble I'm in - that's the only
487 way I'd say some'em. You got tell 'em that shit.

488 CJ: Well why don't you go up there with me.

489 DJ: I'd be in Alabama, get me out a damn ---

490 END OF SIDE OF TAPE

491 CJ: --- help you get out a that shit - I mean 'cause I - you know you was like you
492 know you -- I remember first time we talked when you was in jail, I called (inaudible) I'm your
493 boy, and --

494 DJ: You know what I'm say, you know, that's the only way I'd say something about it
495 -- 15 cash and damn --

496 CJ: But you don't get no money until damn --

497 DJ: I - and I wouldn't go to court.

498 CJ: What and be a witness?

499 DJ: No I wouldn't go to court.

500 CJ: You wouldn't have to if you could get the mother fucker on tape I don't think.

501 DJ: I mean I wouldn't go to court any way - if I did you know what I'm saying, I'd
502 fuck the whole damn thing up - they ain't gone make me go to court, you know what I'm saying -
503 - mother fucker (inaudible) know what I'm saying.

504 CJ: Why wouldn't you do 'at?

505 DJ: Put me on the stand (inaudible)

506 CJ: I mean I feel you - you can trust me, I feel you.

507 DJ: Oh yeah, like I said, it ain't important you know what I'm saying is that - is that I
508 know I'm safe - I'll see what he saying about it if he - it was my brother you know man I - I'd be
509 talking to somebody you know what I mean trying to get him to say some'em. But like I said,
510 you go tell ye boy Stanley I damn you know what I'm saying, I tell him whatever he wants to
511 damn know he get me outta all this shit and 15 thou --

512 CJ: Umm, I mean I'm sure they can help I mean - 'cause I believe you I know you
513 would a told me - but I know for a fact I mean we been boys for a long time -- and I ain't even
514 gone-- I'm on be straight with you I mean - I - you know I was gone come - I wanted to see if
515 you wanted to do anything any way this weekend, see if you gotta work and I don't never get to
516 do shit with my niggers no more.

517 DJ: What do I do man?

518 CJ: But Stanley did ask me if I could talk to this person, you know go off with this
519 person whatever - and you know here we are I mean you know. I mean but you would have to
520 talk to him and see what they can do to help you about that. If you willing to talk we can go up
521 there tonight - I mean you know ah Hell he's up there all the fucking time --

522 DJ: Where at the police --

523 CJ: Yeah.

524 DJ: department?

525 CJ: Yeah. Wouldn't nobody see you, wouldn't nobody hear you -- I mean Hell I been
526 up there before just to - he would helping me get out of a ticket - a damn \$400.00 ticket -- 'cause
527 a fuck boy city caught me and pulled me over -- see I thought Pearl gave me this car, I thought
528 you had 30 days to get a tag and insurance --

529 DJ: Yeah.

30 CJ: you got 30 days to get a tag but you ain't got 30 days to get no insurance - you
531 got like 72 hours to get insurance -- or right then, some shit like that.

532 DJ: I mean yeah, I could set it up you know what I mean.

533 CJ: You know if you'll do this - look I'll tell you what man, if you can Mark Free
534 (inaudible) would you not pimp a liar or some'em - would you not do that?

535 DJ: You serious as Hell ain't you.

536 CJ: Yeah, I'm for real. If you won't, I will - but I don't know if he'll talk in front of
537 me 'cause he don't know me. Be - we can get paid -- I mean and you told me that day you's
538 like, shit \$15,000.00 I'll tell on mother fucker if I don't like 'em. I mean trust me David you
539 know I ain't never been no snitch but I just think this is something that should be done.

540 DJ: (Inaudible)

541 CJ: Yeah, yeah, yeah, yeah.

542 DJ: I - you know what I'm saying, I got damn (inaudible) and shit (inaudible) you
543 know what I'm saying (inaudible) whatever - what ever, when even - how ever --

544 CJ: See that - I mean that's what I'm saying it's like --

545 DJ: (Inaudible) you go up there --

546 CJ: You know, I mean, you - I ain't been to fuck you over you know I ain't done
547 nothing to hurt - I - like I told somebody you know I mean if it was -- if it was you that done that
548 shit it'd be hard as Hell for me to tell I - I probably wouldn't do it - I wouldn't do it - you know I
549 mean I - but then again you gotta think of it like you know you took somebody's life for no
550 reason - where's this shit at?

551 DJ: I'll show you -- (inaudible)

552 CJ: Right here?

553 DJ: no, go on down past that sign it's right past that sign - right here. Pull on up there

554 (inaudible)

555 CJ: Damn I hate this driveway.

556 DJ: (Inaudible) I'll be back in a minute.

557 CJ: Alright. Ya'll have to get a cop or some'em to pull me over and me in the back

558 of his car get this wire off me Stanley. 'Cause if he finds out I got this on man he ain't gone talk.

559 Please do some'em get this wire off me. He's already trying to check me, feel on me. Here he

560 comes I'm on shut up. Give me a light.

561 DJ: Go to the trailer park.

562 CJ: Trailer park?

563 DJ: Yeah don't do that dog, don't do that shit you gone fuck everything up -- you got

564 it come on.

565 CJ: You nearly scared the shit outta me.

566 DJ: Go right. So I see, what's up where I can get my fucking money -- I don't know

567 you know what I'm saying. You tell him what I said then we go from there. But I know it ain't

568 gone help you goint up there saying, I mean you know -- I don't know a lot but I bet I know a

569 bunch a shit that'll help you know what I mean.

570 CJ: If we can just put this fucking puzzle together - I mean if we could find out where

571 in the Hell the gun was - I think a deer rifle was used.

572 DJ: Pull in right here - just part right there on the side, right there. Come on.

573 CJ: Hum?

574 DJ: Come on this fine.

575 CJ: Hurry up, I need to hurry up and get up there with (inaudible) --

576 DJ: I mean I'm saying come on right there.

577 CJ: Huh?

578 DJ: Come on. Come on.

579 CJ: Man just hurry up.

580 DJ: Come on Nikki ain't here I'm on go holler at Brian.

581 CJ: Man just come on. Stanley I'm in a - back here in a trailer park man find a way

582 to please get this wire off me. He here?

583 DJ: Yeah, they upstairs. Nikki and everybody's up there

584 CJ: Up where?

585 DJ: Upstairs.

586 CJ: That fool fucked me up dog.

587 DJ: There's you one Corey.

588 CJ: Shit.

589 DJ: (Inaudible)

590 RADIO TURNED UP

591 CJ: Which one these mother fucker is Phillip live - ain't it Phillip's --

592 DJ: Huh?

593 CJ: Ain't it Phillip or some'em.

594 DJ: Pull right here. Man I need my money.

595 CJ: How much he owe you?
596 DJ: \$20.00 and I need it tonight 'fore he spends it. Come on. Hi. Penny, where's
597 everybody at? You don't need to be drinking and driving -- where you going, to the club?
598 Unk: Yeah, me and Ray was going.
599 CJ: Who?
600 Unk: Me and Ray
601 CJ: Oh.
602 Unk: I'm go -- I'm just see what's going on --
603 DJ: Who's all going?
604 Unk: I'm taking Ray to the club.
605 DJ: Where's Vickie and 'em?
606 Unk: I (inaudible) you checked down (inaudible)
607 DJ: Huh, yeah, I done checked down there -- he owes me some money -- I wanna go
608 to the club.
609 Unk: Ah, Hell no - you ain't even got license have you.
610 DJ: Uh-uh, I ain't no designated driver I'm on get fucked up too, what's wrong with
611 ya'll.
612 Unk: You don't want to - go down there they I.D. you -- the police come in I.D.
613 DJ: I ain't going then, I ain't -- but I - I gotta find them.
614 Unk: Brian and them was just up there a few minutes ago.
615 DJ: I know man he said they went up Tony's house.
616 Unk: (Inaudible)

617 DJ: We - we fixing to on the way up there --

618 Unk: Check on --

619 DJ: I got get my money 'fore he spends it you know how he is - -they IDing though?

620 Unk: Yeah they IDing -- that night Tommy and Brian we got --

621 DJ: Hey, I can call up there can't I and you can tell me if they some girl and shit up

622 there can't you.

623 Unk: Yeah.

624 DJ: And tell her - tell your sister if anybody calls up here and it's David put you on the

625 phone -- I'm serious 'cause I'm on come up there.

626 Unk: That's my boyfriend's (inaudible)

627 DJ: Yeah I know, where's he at?

628 Unk; At work.

629 DJ: I'm telling--

630 Unk; I'm getting (inaudible)

631 DJ: I'm telling -- I ain't no player hater - I'm a participator.

632 Unk: Honey I'm a player buddy, I'm tired of men playing I'm on play with these mother

633 fuckers -- and then and her -- his old lady when he gets in my car, she's gone shoot that mother

634 fucker.

635 DJ: She gone what?

636 Unk: She gone shoot Michael.

637 DJ: Why, I - I need get the fuck away from here.

638 Unk: Hell, she's so damn jealous of me and him now, him getting in my God damn car --

639 I'll take his ass right along with me won't --

640 DJ: Just tell 'em, fuck it - he wanting to party ain't he, you show how to party.

641 Unk; I'll party --

642 DJ: Well, we'll see you Penny - I'm on call up there now in about 45 minutes.

643 Unk; You know the number?

644 DJ: I'll look it up or some'em.

645 Unk: 232-9300.

646 DJ: 9300, alright. Redneck bar dog, them mother fuckers don't know what to think

647 about me. Man that shit sucks. I - I hook you up with some gas money dog for this ride. You

648 hear me?

649 CJ: (Inaudible) I got it my own.

650 DJ: (Inaudible) I ain't got no car.

651 CJ: You know but you --

652 DJ: I'm on get my damn money 'fore them son-of-a-bitches spend it man. (Inaudible)

653 CJ: Where we going now?

654 DJ: Go uh, go left - go on up to the top.

655 CJ: Where's Tommy live at where we went and seen 'at - that woman 'bout cashing

656 them checks.

657 DJ: Nah, that's his mamma -- he lives across the street (inaudible) You been to

658 Tommy's house -- go left.

659 CJ: (Inaudible) He live with your brother?

660 DJ: Do what?

661 CJ: He live with your brother?

662 DJ: Uh-uh.

663 CJ: Don't your brother live down there though?

664 DJ: Uh-uh. I know this is where they at - (inaudible)

665 CJ: Who's Tommy live with?

666 DJ: Uh, his daddy -- well he lives with his daddy and his mamma.

667 CJ: Thought they lived in the trailer park.

668 DJ: No, Phillip lives in - they moved from the trailer park. You remember where

669 Adam Cagle used to live?

670 CJ: Where's it at - on this road?

671 DJ: Yeah. (Inaudible) All my family lives close together dog and I live out in fucking

672 Coosa. We 'bout hit some deer the other day right here - that shit's fucked up - (inaudible) You

673 know where Powell's is?

674 CJ: No. That closed liquor store man?

675 DJ: This - this store right here.

676 CJ: Yeah.

677 DJ: Turn right here.

678 CJ: Now where?

679 DJ: Right there where that um, truck is. Oh, son-of-a-bitch. You got all your

680 insurance and shit?

681 CJ: Yeah.

682 Unk: How you doing?

683 CJ: Alright.

4 Unk: Officer Fincher, County Police, need to see your driver's license and insurance
685 please.

686 DJ: What was the reason you pulled us over officer?

687 Fincher: Mr. Cagle?

688 CJ: Yes sir.

689 Fincher: Step out of the car for me. You had anything to drink tonight?

690 CJ: Um-um.

691 Fincher: Sure?

692 CJ: Positive.

693 Fincher: Smell a little bit on you okay, I want you to come back to the car, I want you to
694 take the test with me, alright.
