5 SS: 'Kay, this is uh, Sgt. Stanley Sutton with the Floyd County Police Department -
6 'day's date is January the 9th of the year 2001, the time is uh, 14:06 hours, 14-06 hours, 2:06 PM
7 in the afternoon - the day is um, Tuesday - 'at - Tuesday, today's Tuesday, I'm interviewing a
8 subject by the name of Jason Cheatwood in reference to an incident that occurred in Polk County
9 in Cedartown with Aislynn Hogue and Jason was with her on the night of the that a incident
10 happened concerning a - a boy by name of Joey Watkins - Joey Watkins was her boyfriend at one
11 time -- Jason, for the record, state your name please.

12 JC: Jason Rodney Cheatwood.

13 SS: What's your address Jason?

14 JC: [REDACTED] Lewis Road.

15 SS: And where's that at?

16 JC: Cedartown, Georgia.

17 SS: What's your date of birth?

18 JC: [REDACTED]-82.

19 SS: [REDACTED]-82?

20 JC: Yes sir.

21 SS: Okay, and your Social Security Number.

22 JC: [REDACTED]

23 SS: 'Kay, uh, Jason uh, are you familiar with a Aislynn Hogue?

24 JC: Yes sir.

25 SS: How long have you known her?

26 JC: For a while now.

27 SS: How long is for a while?

28 JC: 'Bout two years.

29 SS: Was there an incident where someone was chasing her or anything in a car in
30 Cedartown?

31 JC: Yes sir.

32 SS: Were you with Aislynn?

33 JC: Yes sir.

34 SS: Alright, just tell me what happened in your own words.

35 JC: Alright, we was setting at uh, H & R Block uh, parking lot --

36 SS: And where's that located at?

37 JC: In Cedartown.

38 SS: Uh-huh.

39 JC: And we's setting there, I's talking to some of my friends and he pulled up telling
40 her that uh, that they needed to talk and she said, "no, no" - then he started taking off his shirt
41 and then she left, she pulled out of the parking lot and then he just kept following her, he followed
42 - we went through uh, Kroger parking lot try to turn around get - you know where he wouldn't -
43 you know - stop following us - then finally he - we left him some how.

44 SS: He - he followed you in her car - I mean what car was he in?

45 JC: His car I reckon, a red Trans-Am - think.

46 SS: And why did he take off his shirt?

47 JC: I guess gone try to fight me.

48 SS: Did he say anything to you?

49 JC: No sir.

50 SS: He - he - did he - was he cussing or anything?

51 JC: Yes sir.

52 SS: What was he saying?

53 JC: He just - I can't remember exactly what he's saying 'cause - I didn't know what
54 was going on.

55 SS: What was his demeanor - was he talking normal or how was he reacting?

56 JC: He - he got kinda mad 'cause he took off his hat and his shirt.

57 SS: Was anybody with him?

58 JC: Yes sir, I don't know some boy was with him, I don't know who he was.

59 SS: And what did he tell Aislynn?

60 JC: He's - he's like, we need to talk, we need to talk and she's like, no we don't no -
61 then he took off his shirt -- and she said "don't start" and then we just pulled out the parking lot -
62 and he just followed us.

63 SS: 'Kay did uh, what kind a car was she in?

64 JC: Uh, her car, '99 Cavalier.

65 SS: Is that the first time you ever seen him?

66 JC: Yes sir.

67 SS: Did she tell you who he was?

68 JC: Yes sir.

69 SS: Did she tell you - you know - was you in the car with her?

70 JC: Yes sir.

71 SS: What kind a car did you say she had?

72 JC: '99 Cavalier.

73 SS: What color?

74 JC: White.

75 SS: Do you know when this happened?

76 JC: It's at the uh, end of August - it's night time.

77 SS: What time was it?

78 JC: Ah, 'bout 8:30 - 9:00, something like that.

79 SS: And this happened in Polk County, Cedartown.

80 JC: Yes sir.

81 SS: And when ya'll went out of the Kroger's parking lot, was he - was he still

82 following you?

83 JC: No sir - 'cause we like got out in front of a car so he couldn't get behind us.

84 SS: So, --

85 JC: And we turned off the road and went to uh, Ronnie Worthington's house.

86 SS: Who's house?

87 JC: Ronnie Worthington's.

88 SS: Okay, what was she saying when - uh, when - when this was going on - did she tell

89 you who he was?

90 JC: Yeah, her ex-boyfriend and really that's it.

91 SS: Okay, but you was there when he come up and wanted to talk and pulled his shirt

92 off and everything.

93 JC: Yes sir.

94 SS: And he was cussing.

95 JC: Yes sir.

96 SS: Was this outside the parking lot - uh, where you were at - in Polk County?

97 JC: No, it was in the parking lot.

98 SS: It happened in the parking lot at Polk County.

99 JC: Yes sir.

100 SS: Did he hit you or anything?

101 JC: No sir.

102 SS: And you said he was cussing.

103 JC: Yes sir.

104 SS: Cussing at her or cussing --

105 JC: Yeah he's cussing at her.

106 SS: You don't know exactly what he said?

107 JC: No I can't remember.

108 SS: 'Kay and then you - you and her drove on to Ronnie Worthington's house.

109 JC: Yes sir.

110 SS: Is that some kin folks of her's?

111 JC: I think it's her uncle.

112 SS: And what happened then?

113 JC: The he followed us back to uh, Kroger to get my - Kroger to get my car - and -

114 and he drove her car and she rode with uh, his daughter back to their house.

115 SS: Do what now?

116 JC: Um, we went back to Kroger to get my car --

117 SS: Yes.

118 JC: -- then uh, he drove her car --

119 SS: Who did?

120 JC: -- Ronnie Worthington.

121 SS: Alright, drove her car.

122 JC: Yeah, and she got ride with her daughter.

123 SS: Uh-huh.

124 JC: I mean with his daughter.

125 SS: Right.

126 JC: And then went back to uh, Aislynn's house.

127 SS: Did he follow you then?

128 JC: No sir I didn't see him then.

129 SS: You didn't see him then. And this is the only thing that you know about Joey?

130 JC: Yes sir.

131 SS: Okay, this is ending the interview with um, Jason Cheatwood on January the 9th,
